

# A MESSAGE FROM THE PRESIDENT/CEO



Dear Friends of SpiriTrust Lutheran,

As I reflected on the accomplishments of SpiriTrust Lutheran<sup>®</sup> in 2017, I quickly realized that there was a common theme to our work – investment in the community. Because of your support we were able to invest in the lives of more than 22,000 residents, clients and participants by providing more than \$8.6 million in benevolent care in 2017 – *an increase of \$1.7 million over the previous year!* We are extremely grateful for your generosity because without your support we certainly could not have served all these people. And for that, we thank you from the bottom of our hearts.

Last year, we reported the long awaited news of being granted permission to expand our ministry of skilled care to SpiriTrust Lutheran<sup>®</sup>, The Village at Luther Ridge in Franklin County. Our investment in the new care center began this winter and is expected to be completed and ready to receive our first residents in the spring of 2019. This new center will support the care of 40 residents, including individuals already living on the campus, as well as residents from the surrounding community.

SpiriTrust Lutheran® Volunteer Income Tax Assistance (VITA) volunteers and team members prepared and filed federal, state and local income tax forms for 4,694 tax payers. Combined federal and state tax returns completed through VITA resulted in nearly \$7.3 million being returned to York County residents, impacting the lives of 7,295 taxpayers and dependents. When factoring in the out-of-pocket savings achieved through this free tax preparation program, the total community economic impact is nearly \$8.6 million.

At the start of the year we launched two initiatives to help our team members grow and develop as leaders. The first initiative, the "Trusted Leaders Academy", brought 24 future leaders from across the agency together to increase their skills as leaders. As part of the curriculum, team members were tasked with solving real-world challenges the agency faces every day. The second initiative, "Lean Way", empowers our employees to suggest changes focused on eliminating waste to help the agency be more effective. Both of these investments support our legacy and heritage of providing exceptional care to all.

This past summer we faced the challenge of evacuating 99 residents from the skilled care center at The Village at Sprenkle Drive. While this event disrupted the lives of residents, families and staff, the compassion that the staff showed during this difficult time truly brought out what it means to be SpiriTrust Lutheran. For more than 45 days, team members traveled to 15 different skilled care centers to ensure that our residents were receiving the care they have come to expect when they placed their trust in us. From the safe evacuation of the first resident until the last resident was brought home, the core values of SpiriTrust Lutheran never shined brighter. Our investment in preparedness training truly paid dividends.

These are just some of the ways SpiriTrust Lutheran has been able to invest in our community thanks to your support. As you read through the pages of our Donor and Community Impact Report, I hope you share the same pride we do knowing that these investments could only be possible because of your generous investment in support of our mission.





# Taking care to a new level.



The assignment Michael Allen-Hall was given in 1996 is finally on its way to completion. Michael Allen-Hall began his architectural career in Washington D.C. before he was recruited to work for Noelker and Hull Associates, Inc., a well-known firm located in Chambersburg. Shortly after he arrived in Franklin County, Michael was asked to perform a planning study for a nursing facility at what we today know as SpiriTrust Lutheran<sup>®</sup>, the Village at Luther Ridge. Like many planning studies, this project was filed away and never acted upon.



Thanks to strong perseverance and tenacity, The Village at Luther Ridge is adding a skilled care center to complete its family of services in Spring 2019. More than 20 years have passed since Michael's initial assignment. Technology has advanced. Trends in senior living have changed. Healthcare delivery has transformed and evolved. What didn't change was the need for skilled care in Franklin County. And, the designer for the project has remained the same – Michael Allen-Hall!

Michael has witnessed the senior living industry shift its focus of providing care to a large volume of residents efficiently, to providing resident-focused care in smaller groups, now called neighborhoods, to provide more person-centered care. - Two skilled care households for 15 residents each
- $\cdot$  A short-term rehabilitation center for ten residents
- A rehabilitation gym
- Access to outdoor spaces
- Resident rooms located close to the common areas to encourage residents to participate in community life
- Work stations and supplies used by nurses and other caregivers will be discretely integrated into the home-life environment

# Because life is better with friends.

"It is more blessed to give than to receive," was a common phrase repeated in the home of Victor Brown, a volunteer in the SpiriTrust Lutheran<sup>®</sup> Senior Companion Program. Victor has a long track record of being involved in community development and reaching out to help improve the lives of others, so when he learned of the program, he reached out to Lambrini Nauss, director of the Senior Companion Program. That's when he met Robert.

"I enjoy spending time with Victor—he is a true friend," says Robert Crouse, a client of the program. "I enjoy talking and doing activities with him, like visiting Lake Redman, going on trips to Mack's Ice Cream, and going to the Northeastern Senior Center where we play cards, paint, and eat lunch."

The program is designed for volunteers, ages 55 or older, to help keep other older adults connected with the community and improve their overall well-being with one-on-one visits once a week. Volunteers are provided a tax-free stipend, mileage reimbursement, paid training, and vacation and sick time. These interactions offer a chance for volunteers and clients to connect, listen, and offer encouragement.

"Volunteering and spending time with the clients helps me realize how blessed I am, and the impact that one person can have on another's life," says Victor.

Sharing conversation, going to art galleries, and even volunteering at the York County Food Bank to give back to the community are just a few ways Victor and his clients spend time together.

"If I have a doctor's appointment, need to get items from the store, or even hang a curtain in my home, I know I can count on Victor and the program to help me get those things done. Victor and the program have provided me with companionship and a positive outlook on life. If you want a friend—join the Senior Companion Program," says a smiling Robert. With the help of our donors, the SpiriTrust Lutheran Senior Companion Program is able to help volunteers make an impact on someone else's life, while providing companionship and support to other older adults through the sharing of time, hobbies, and other recreational activities. In 2017, with the help of 57 volunteers, 195 clients were served through the program. Since its inception in 1999, the Senior Companion program has served 1,875 clients in York County.

Our clients know somebody cares about them and they are there to help and encourage them. We are grateful for the impact our supporters are making in the lives of those in our community. Thank you for your partnership!

# Dignity every step of the way.

Plans were underway for Frances Gilbert's 93rd birthday when previous health issues began reemerging. After consulting with doctors and reviewing treatment options, many of which involved hospitalization, her family felt the best option for Frances was to move forward with hospice services. SpiriTrust Lutheran® Home Care & Hospice was called upon to bring that much needed care into her own home. With nurses making visits once or twice daily, as well as on the weekend, Martha and her family had team members to talk through aspects of care continuously.

"I remember Mother being restless the day she passed. The aide came and was so peaceful with her. She changed her gown, and gently rubbed lotion on her. She knew exactly what my mother needed," Martha recalls emotionally.

Being at home enabled Frances to stay comfortable in a familiar place surrounded by loved ones. "The staff was just so caring and immediately got back to us when we had questions," recalls Martha Martin, Frances's daughter. "The dignity Home Care & Hospice gave my mom and the aides was just beautiful. Even though there was a lot going on and Mother might not have understood everything that was happening, the nurses talked to her and explained what they would be doing every




